Write in the type of security, for example 10p Ordinary Shares (this should be shown on the certificate).

Write the amount of shares you wish to transfer. You do not have to transfer the entire certificate.

Give the name and address of the owner(s) known to the register (this should be shown on the certificate)

If the transfer is not made by the registered holder(s) insert also the name(s) and capacity (e.g. executor(s) of the person(s) making the transfer.
